



2016/17 PEE WEE SKI CAMP

Looking for a fun, basic introduction to skiing for campers with little to no experience on the slopes? Brimacombe's Pee Wee Ski Camp is a great way to make your child's first experiences memorable, as they develop new friendships along with basic skiing skills, including important safety lessons.

The Pee Wee Ski Camp runs for six consecutive weeks with sessions offered on Saturdays or Sundays from 10:30 a.m. to 12:00 p.m. Weather permitting, our 2016/17 Pee Wee Ski Camp is scheduled to begin the weekend of January 21 & 22, 2017.

The cost is only \$100.00+hst for all six weeks. If your child has a season membership, he/she can receive an additional 15% off the Pee Wee Ski Camp rate.

All campers will receive a lift ticket valid for the duration of each weekly session and for 30 minutes afterwards (10:30 am-12:30 pm).

Ski Camp sessions are offered for children ages 6-12 in the following categories:

GROUP 1 – has never skied before.

GROUP 2 – has skied, but cannot make controlled turns.

GROUP 3 – makes linked snow plow turns in both directions.

GROUP 4 – makes linked turns with skis together early in the turn.

GROUP 5 – skis parallel most of the time.

If your child is new to the Camp, please use your best judgement and the chart above when indicating their ability level on the application form. If your child is a returning camper, enrolled in last season's Pee Wee Ski Camp, he/she will be placed in a group according to our records. If your child has outgrown or graduated from the Pee Wee Ski Camp, or simply wants to move on to snowboarding, consider continuing the learning process with the certified instructors at Brimacombe Snow School (905-983-6451).

The Pee Wee Ski Camp has limited availability and fills up quickly. In order to avoid disappointment, please fill out the application and waiver, and mail it back to us immediately. Applications will only be accepted with a COMPLETED application form and waiver (please read carefully) and payment. Participants may be required to show proof of age upon request.

NEED EQUIPMENT?

There are several options available for equipping your child with everything he/she needs to hit the slopes this season.

- *Six-week rental packages* are available to all Camp participants for just \$90+hst. To take advantage of this great rate, you can pre-order your package on your Pee Wee Ski Camp Registration Form or drop-in at Brimacombe's Slopeside Rental Shop. Please call 905-983-7669 ext. 226 for details. *Please note: Rentals will be available for pick-up from Dec.1-23, 2016, on a first come first serve basis, while supplies last. Rentals must be returned the last day of program. A full rental charge will be applied to all late rentals. A credit card or cash deposit of up to \$350 is required on EACH equipment rental and all renters under the age of 18 require a parent/guardian signature on the rental agreement.*
- If you are interested in *purchasing new equipment*, Junior Ski Packages — includes skis, boots, poles and bindings — are available in Brimacombe's Slopeside Retail Store starting at only \$329+hst! Brimacombe's Slopeside Retail Store will be open 7 days a week beginning November 12, 2016.
- For *great deals on used equipment*, we recommend you visit Brimacombe's Annual Ski & Board Swap. Date & location to be announced.

SKIING BEFORE AND/OR AFTER YOUR LESSON

Non-members wishing to ski before and/or longer than 30 minutes after a camp session must purchase a lift ticket. Several options are available:

- A Beginner Lift Pass is available for only \$15.95+hst each day from any ticket kiosk. This pass is valid during the day of purchase on the *Bambi* run and Magic Carpet conveyor lift found on the eastern side of our facility.
- If you wish to have access to all of the runs and lifts, a Half-Day or Full-Day Lift Ticket is required and can be purchased daily at any ticket kiosk. Please refer to our brochure or visit brimacombe.ca for a complete list of lift ticket rates.

For unlimited access to all lifts and runs for the entire season, as well as the convenience of staying for as long as you want, we suggest investing in a membership. Memberships for children ages 5 and under are free with the purchase of an adult or senior membership; memberships for children 13 and under start at only \$392+hst for the entire season.

ASSUMPTION OF RISKS

I am aware that skiing, snowboarding and participating in lessons/camps/program activities involve many risks, dangers and hazards including, but not limited to: boarding, riding and disembarking ski lifts; changing weather conditions; exposed rock, earth, ice, and other natural objects; trees, tree wells, tree stumps and forest deadfall; the condition of snow or ice on or beneath the surface; variations in the terrain which may create blind spots or areas of reduced visibility; variations in the surface or sub-surface, including changes due to man-made or artificial snow; variable and difficult conditions; streams, creeks, and exposed holes in the snow pack above streams or creeks; collision with lift towers, fences, snow making equipment, snow grooming equipment, snowcats, snowmobiles or other vehicles, equipment or structures; collision with other persons; loss of balance or control; failure to act safely or within one's own ability or to stay within designated areas; negligence of other skiers, snowboarders and other persons; and **NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE.** I am also aware that the risks, dangers and hazards referred to above exist throughout the ski area and that many hazards are unmarked. I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Oshawa Ski Club o/a Brimacombe permitting my participation in the above mentioned "Program" and permitting my use of the lifts, ski runs, trails, terrain parks, race courses, restaurants, day lodge and other ski area facilities (hereinafter "the facilities"), snow school, lessons and programs and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Oshawa Ski Club o/a Brimacombe, and their directors, officers, employees, agents, and representatives and any volunteers in any way associated with the Program, and the Program Sponsors (all of whom are hereinafter collectively known as "The Releasees"); and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my use of or my presence on the facilities DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE **OCCUPIERS LIABILITY ACT, RSO1990, c.02** ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE;

TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability from property damage or personal injury to any third party, resulting from participation in "the Program" or use of the facilities; AND THAT, this Release of Liability shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns in the event of my death or incapacity. This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Ontario and no other jurisdiction; and any litigation involving the parties to this Agreement shall be brought solely within the Province of Ontario, and shall be within the exclusive jurisdiction of the Courts of the Province of Ontario.
